Background

Orontide is a specialist engineering, preservation and maintenance services company, operating in the Mining and Resources; Oil and Gas; and Defence and Commercial Marine industries in Western Australian for over 40 years.

Challenge

The Australian Department of Defence has implemented the Defence Industry Security Program (DISP) to minimise third party risk and enforce strict cybersecurity standards on contractors they work with. Because Orontide delivers services to the Department of Defence, it needed to meet the DISP requirements across the 4 key outcome areas:

- ▶ Governance
- ▶ Personal Security
- ▶ Physical Security
- ▶ Information security

Orontide needed to find a trusted partner to help work through the program requirements and achieve DISP membership to be able to continue delivering services to the Department of Defence.

Project Brief

Orontide engaged Red Piranha to help them understand what was required of them to achieve DISP membership, across a full range of areas:

- ▶ DISP accreditation

Solution

Cyber Security Review (CSR)
